

Political Prisoners in America

The American Gulags, Federal Prisons, Detention Centers, Military Prisons, Army / FEMA Detention Camps contain thousands of political Prisoners, convicted of violations of Laws which do not exist, by Federal Courts which have no subject matter Jurisdiction, prosecuted by a Justice Department which disregards both the United States Constitution and the actual Laws passed by the US Congress.

The federal courts lack **Subject Matter Jurisdiction** for Criminal trials on Income Tax violations. The congress has never given the Federal District Courts, Appellate Courts, or the Supreme Court Subject Matter authority to criminally prosecute any citizen for non-compliance with any 26 CFR Laws regarding Income Tax violations. The congress has conferred only **CIVIL Jurisdiction** for Income Tax violations. This is found in 28 USC sections 1340 and 1346. It is repeated in the Internal Revenue Code, Book 68A in section 7402 (f), conferring only **Civil Jurisdiction**. This is because NO sections of 26 CFR make any non-compliance with the “ Voluntary “ Income Tax scheme a criminal act. So we have thousands of citizens which have been charged with false crimes where there is no law, by a USDJ which has no statutory subject matter authority to conduct an “ Investigation “, or bring any criminal charges, with kangaroo mock court trials held in US District Courts with no statutory authority, as they lack **Subject Matter authority**. The US District Court Judges refuse to allow the USDJ to be forced to answer any questions, or produce any evidence that a Statute Law has been violated, at the same time, refusing to allow the defendant’s motions for lack of Subject Matter jurisdiction, and refusing anyone to bring any factual law into the case. Any Defense Lawyer who refuses to quickly follow the rubbish handed down as orders from the court Judge, quickly finds himself sanctioned, fined, and loosing his right to practice before the Federal Courts.

In this case, and many others, the USDJ Lawyers and the US District Court and the Appellate Court Judges are **openly committing criminal acts**, directly violating 18 USC 241 Conspiracy to deprive a US Citizen of his constitutional rights, 18 USC 1018 Issuance of False Documents to commit fraud, 18 USC Chapter 73 with multiple counts of Obstruction of Justice, and the Judge is violating his oath of office and 28 USC 372 (a). Ref: Wilton v. Seven Falls Co., 515 US 277 and General Electric Co. v Joiner, 522 US 136. **All of these are Federal felonies**. So here we have the Criminals representing the Government, and sitting on the bench, acting with impunity to crush any citizen who is stupid enough to question their lawless acts. This is the **greatest criminal conspiracy in history**. The Supreme Court is fully aware of the criminal acts perpetrated by the USDJ and the Judges, but simply refuses to take any case which is about the Income Tax, or a Criminal Conspiracy case which is based upon unproven illegal charges relating to an Income Tax which does not exist.

This actually is nothing new.

Since the beginning of America, native Americans were murdered in **mass genocide**, their lands expropriated, and by miracle, the Government now owned the land, which the Government sold off, at a hell of a profit, mostly to insiders. Gold was found, quick, run those Indians off that land, put them on reservations in the desert, starve them to death, and get them out of the way of **profit making**. The US Constitution says nowhere that the Federal Government owns the land, or even can own land. It has worked very well to make the insiders into the new rich in America. The Founding Fathers were already men of property, all of them who were wealthy, had earned their own fortunes. Many who were founding fathers were never wealthy, but working persons who worked for the common good, and wanted a true opportunity at freedom. As the beurocracy grew, the lust for more power and profits grew exponentially. Then entered the European Bankers Cartels. Thousands of settlers, who had worked so long and hard conquering the new country found themselves screwed out of their land and built wealth, by “Trusts” with courts which cared not to obey the laws or the U S Constitution, or State Constitutions.

In the 1920’s thousands of citizens were imprisoned on trumped up charges which did not exist, as there was no Statute Law on that issue. Thousands of citizens **have been found guilty of crimes where there were no crimes**, and have lost all their civil rights, property, and freedom. They just became “Enemies of the State”, who were to be disposed of, by whatever means was expedient. Nowhere in the constitution does it give authority to the Federal Government to **remove** a Citizens constitutional rights. The US Congress just usurped the right, and the criminal Federal courts allowed it, and were complicit in providing a forum to make it all look legal. The US Congress is composed of whores, who sell their souls, **and our country** to whoever has the most money for them. They actually sold the whole country, lock stock and barrel to the Banking Cartels.

Same thing in World War II, when the **Federal Reserve Banks** openly confiscated the bank accounts and property of all persons ordered into the Internment Camps. The Federal Reserve Banks are each **privately owned banks**, and **no Law** allowed them to do any such thing. But the Courts would not intervene. Thousands of **American Citizens** died in the camps, and thousands who were let out after the war returned to their former home to find **they were totally destitute**, and their property now belonged to others. Each time one of these organized thefts has occurred, somehow the **well connected insiders** profited handsomely, and the courts refused to intervene.

Same thing in the 1960’s, when the Black organizations became **Enemies of the State**, were arrested, incarcerated, property confiscated, and permanently silenced by murder or imprisonment. Thousands of citizens who questioned the authority of the Federal Government to do all kinds of searches, surveillance, murders, arrests, seizures, and beatings were themselves branded as “Subversives”, and found the wrath of the Federal monster down on their back, with illegal prosecutions, and “official murder”. The mass media, owned by mega Jew banker trillionaires, printed only compliant propoganda.

In the 1910's the majority of the **Democratic Party was taken over by Communists**, who rephrased their ideals, and pushed through new laws to expedite the enslavement of all of America into a slave state, with a new "Income Tax" on citizens. This was declared **unconstitutional** by the Supreme Court in 1916, as was the 3 times before that when an income tax was passed by the Congress. The World Bankers were behind all this effort to enslave America, and still are. Now the name has changed to **One World Order**, and is fast approaching total world domination. The US Military is their enforcement arm, and the continuing "Police Actions" wars crush all who oppose them.

Enter the Internet, and at last the big money control of all published and broadcast media has suddenly become obsolete. Americans can freely communicate and exchange ideas, and tell each other **the truth**. Now a new phenomena has emerged, organizations which have sprung up to spread the truth about the evils that the Government beurocracy is doing, which parts are illegal, and are making an **organized fight** to take back their own country. So, many have now become **political Prisoners** by the monster Federal Beurocracy, who is fighting back with illegal prosecutions, seizures, and media controlled blitzes. Every penny the IRS takes in Income Taxes is paid directly into the Federal Reserve Banks, and then transferred into off-the-books NSA and CIA accounts.

The United States has more **citizens in prison per capita** than all the other advanced supposed free countries combined. America is the only country where at least 2 million persons know about the CIA being the largest narcotics importer and dealer, and it still goes on. America is the only country where it's agents have gone to other sovereign countries and **kidnapped elected leaders**, to bring them back to be imprisoned for life in American prisons. America is the only country to violate every international treaty and law, to go to other countries, murder their leaders, and seize the government by force. America is not the only country to **commit murder** to maintain the stranglehold of the Federal Government on the general population, but then Russia, China, Iran, Iraq, North Korea, Arabia, and their kind are not noted to be Democratically inclined either.

In most aspects, it has seemed for a long time, that the real object of the US Federal Government has been and continues to be, the **systematic deprivation of Civil Rights** to as many citizens as possible. Once a Citizen loses all civil rights by being a convicted felon, then that is one less for the Government to worry about. Once crushed by the Government, and incarcerated, with no rights, and no property to continue the fight, a person has no will to struggle further. With a Supreme Court who **refuses** to stop the abuses, despair in the general population usually ensues. Only those who can be counted on to maintain the status quo, who are on the public dole, or engaged in direct government business will be left to their own life, such as it is.

The situation has reached complete crisis proportions. The 12 Federal Reserve Banks which are **private companies**, own the whole of America, lock, stock, and barrel. The

banks, which were established in 1913, received an unconditional first mortgage on all of America with the Emergency Banking Act in 1933. **Every penny of Income Tax collected** since that time, \$ 77.4 Trillion, has poured directly into the coffers of the Federal Reserve Banks, and still continues. Congress has no control over these banks, and they collect interest on the national debt to them in **Gold**. The current true national debt is \$ 51 trillion, as of Jan 2007. The assets of all of America, public and private, is currently \$ 49 Trillion, at today's highly inflated values. Something has to give. The Administration has a **contingency plan**, called REX 84, subordinate plans Cable Splicer, and Garden Plot, for the complete takeover of America, getting rid of the 50 states, and having a resultant 10 FEMA districts, with appointed leaders. All the persons who would be in the way, the Supreme Court, Congress, Federal Judges, the State Governors, the State Legislators, tax protesters, nazi's, and the Mayors of all the Large cities will be rounded up, and sent to the death camps. (Anyone can look all this up on the internet).

Thousands of Citizens are organizing into groups, associations, foundations, and just individuals, to attempt to stop the travesties being perpetrated by the lawless USDJ, **lawless Federal Courts**, blood thirsty Bankers, and the 12 mega rich banker families who have run the world for a long time, by peaceful means, using the court system. They are doomed to failure. Thousands will loose their lives, homes, and their liberty to the monster US Government before the end comes. It will come soon, it has to.

America has 3.2 million prisoners in it's prisons. At least 2 % are political prisoners, who have been vanquished for opposing the lawless behavior of the American Federal Government. That is 642,000 political prisoners actually imprisoned. Another 2 million have been raped of all their assets, and livelihood having already been convicted, but not held in prison anymore. When the breaking point is reached, those millions could be pissed off enough to depose this plan to seize the country, and put different people in the Death Camps. Even the 240,000 foreign UN army troops stationed in America which will be called upon to do the genocide on Americans under the REX 84 and subordinate plans cannot hold back a tide of 8 to 9 million armed citizens. But then the Government keeps going ahead with these phony wars, and keeps loosing, so they will go ahead with this deal also, and loose again. When the violence starts, there will be things happening which no one will believe. Imagine thousands of IRS assholes being dragged from their castles, and stoned to death in the streets, and USDJ lawyers being openly assassinated where ever they can be found. Crooked State Judges who have illegally put citizens in prison, using the same lawlessness behavior, and Prosecutors, will be assassinated. Once the violence starts, there **will be no end** until all the evil doers will be eliminated. The Government will try to take everyone's guns in 2007, and have the National ID Cards with ID Chips in them by the end of 2008. The time is near for the last dance. Probably in May 2007, the Israelis will bomb Iran. Then the Arabs will cut off the US Oil supply. How about gas at \$ 14 a gallon, but no gas available. You should check the 16 Presidential Orders in place to be used to take over the country. (also REX 84)

There was a hope, it was started by President Ronald Regan. He picked someone of absolute trust, to go borrow \$ 27.5 Trillion from other foreign banks, to form a cash fund hedge against a spendthrift Congress who was owned by the foreign and domestic banking cartels, and the Federal Reserve acting on their Lien on America, and seizing the country. This man was Leo Wanta, of the Secret Service, who did borrow the money, and held it in his Trust Corporation AmeriTrust Groupe, Inc., for the benefit of the America he loved. The next President saw what was going on, and continued to steal \$ Trillions, take over the CIA Drug Trade business, divert \$ Billions into his offshore business accounts, and his wife's secret accounts, labeled as charities. Enter the son of the Bush crime patriarch as the new President, and the diversion of continuing \$ Trillions of US Citizen paid tax money, escalation of the OWO out into the open, and issuing Executive Orders placing all of the US Government Agencies under the control of FEMA / Homeland Security. The drug trade business continued to pour \$ Billions into the Family and OWO coffers. Leo Wanta was imprisoned to shut him up, and the \$ 27.5 Trillion which was borrowed, diverted into private accounts to fund the illegal activities of the Banking Cartels, the CIA offshore corporations, trusts, and other private accounts. The \$ 27.5 Trillion has grown with interest to about \$ 70 Trillion, and is generating almost \$ 200 Billion a DAY in interest for the Federal Reserve owners (not the US Taxpayers), and the conspiracy has effectively made the US Government appear bankrupt. This is to proceed with the plan of the total takeover of North America, joining all of Mexico, the United States, and Canada into one entity, controlled by the Banking Cartels, through a Fake Government, founded on FEMA, and with no Constitution to worry about. The timetable is fast approaching, as the Loans for the \$ 27.5 Trillion from the foreign banks starts falling due for repayment in 2012, and with the US Government bankrupt, they cannot possibly be repaid. In the meantime, the funds " held in trust " are being illegally used by the corrupt banksters and presidential crime syndicates, laundering the funds thru multiple off-books CIA / NSA entities, and stashing the \$ 200 billion a day interest in their individual off-shore secret accounts. As the entire scheme is about to come unraveled, as word has finally been leaking out into the world, banker gangsters are being terminated, funds seized, government leaders sacked, and the rule of law is trashed, each Citizen Patriot needs to prepare for the final chapter in the saga.
